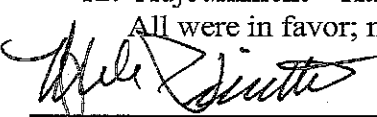

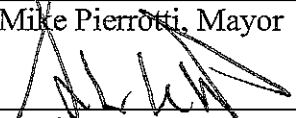

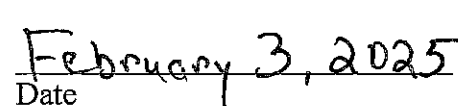
## **Meeting Minutes** **January 8, 2025**
