- 15. Discussion on Park

Kay Hebert stated that at present approximately \$3000 has been spent; park has never been properly kept up in the past and when cameras and lights were installed by past administrations they were dismantled or shot out; Gates hours have not been enforced. Public was given handout for interest and ideas

Several Council members are in favor of letting park to return to the church; Mayor stated community must want to fund the park; Council Erica Francis was not in favor of returning because the church could not afford the upkeep either. The Recreation Park Board did not materialize, provide a budget, etc. Some residents have offered to cut the grass.

16. Police Report: Police Chief was not present

Tickets in amount of \$42,564.00 had not been entered, or had follow up done on them; have applied to Louisiana Debt Recovery for assistance in recoupment

Budget for Police Dept. is in dire starts for the remainder of the year

Council Hebert spoke on the deficits of the budget; serious cuts MUST happen as cautioned previously
