## TOWN OF ELTON STATE OF LOUISIANA ORDINANCE NUMBER 100-09-20 25-20

## AN ORDINANCE TO PROVIDE RELATIVE TO AMENDING SECTION 15.18 OF THE ELTON CODE OF ORDINANCES RELATED TO WATER AND SEWER RATES

**BE IT HEREBY ORDAINED** by the Board of Aldermen of the Town of Elton, Louisiana the following ordinance is hereby enacted to read:

**Section One** Water Rates

Section 15.18(a) is amended to read:

- i. The water rates to residential and commercial customers or users of the municipal water system situated within the municipal corporate limits shall be as follows:
  - a. Residential Water \$31.50 flat rate for first 2000 gallons; \$7.75 per 1000 gallons thereafter
  - b. Commercial Water \$41.50 flat rate for first 2000 gallons; \$8.75 per 1000 gallons thereafter
- ii. The water rates to residential and commercial customers or users of the municipal water system situated **outside the municipal corporate** limits shall be as follows:
  - a. Residential Water \$36.50 flat rate for first 2000 gallons; \$8.75 per 1000 gallons thereafter
  - b. Commercial Water \$46.50 flat rate for first 2000 gallons; \$9.75 per 1000 gallons thereafter

**Section Two** Sewer Rates

Section 15.18(b) is added to read:

i. The sewer rates to residential and commercial customers or users of the municipal water system situated within the municipal corporate limits shall be based upon water consumption and shall be as follows:

## Section Four Effective Date of Ordinance and Adjusted Rates

- A. This ordinance shall become effective on the date of signature by the Mayor if returned within ten days, or ten days after presentation to the Mayor if not signed and returned by the Mayor, or if vetoed, upon the date of override of such veto.
- B. The rates set forth in Section One (Section 15.18(a)) and Section Two (Section 15.18(b)) of this ordinance shall become effective on the first day of the first billing period for water and sewer rates occurring after the effective date of this ordinance.
